SPONSOR QUALIFYING STATEMENT

SPONSOR, it is your responsibility to provide a thorough written statement, qualifying your candidate for the Hall of Fame. Please include the necessary information, along with proper documentation of your candidate's achievements. Please type or print your statement on a separate piece of paper and attach it to the application.

This is very important as should this application be submitted incomplete, your candidate will not be considered for election into the Illinois NSA/BPA Hall of Fame.

If nomination procedures are completely met, but your candidate is unsuccessful in his/her first attempt, your candidate will automatically remain under consideration for a period of five years. The candidate would have to be resubmitted, if not elected, after the fifth year of consideration.
